6. The raft must not be used for commercial purposes.
7. They understand the **RELEASE OF LIABILITY**: There is a degree of risk involved when Rafting. Participants should be aware that NZRA cannot guarantee their safety, and that such risks could include personal injury, illness as a result of poor weather conditions, property damage, death etc. We reserve the right to withdraw hire to any person who in our opinion is likely to endanger themselves or others. We also reserve the right to cancel hire if we become concerned for your safety or any other persons, for any reason. **EXCLUSIONS**: To the extent permitted by law, all our liability for damage to your property, disruption to travel plans, mental or physical injury is excluded. This exclusion is subject to any rights or remedies you may have under the Consumer Guarantees Act 1993.
